- 1. Tender should be submitted in prescribed forms duly filled up with ball-point pen without overwriting and signed with place & date and also to be stamped corrections if any should be initialled, stamped and dated.
- 2. The cover of tenders should be superscripted as 'TENDERS FOR SUPPLY' OF INPUTS' UNDER NMOOP, MM-III and Tender No. AGRI(R&E_/AGRI/2015-16/1 addressed of the tenders should also be clearly indicated on the cover.
- 3. Photo copy of valid authorization/Distributorship/Dealership certificate from the concerned Principal manufacturers or Marketers duly attested by Gazetted Officer/Notary should be enclosed. Original Certificate should be produced at the time of opening of Tenders
