Terms and Conditions
(For Supply of Pig Feeds to NLUP Piglet Multiplication Centres)

1. NLUP Implementing Board has decided to subsidize pig feeds @ Rs. 10/- per Kg. for each type of feed.
2. Two types of pig feeds are required namely, Starter and Finisher feeds.
3. The pig feeds will solely be for the 12 functional Piglet Multiplication Centres (PMC) under NLUP.
4. The entire fund for subsidizing the pig feeds will be borne by the NLUP Implementing Board.
5. Only good quality pig feeds shall be supplied. Brand name/name of company and statement showing composition of feeds so provided, should be submitted for consideration.
6. Requirement for pig feed per month is 201.30 qntls. and the total amount of subsidy per month will be Rs. 2,01,300/-.
7. The quotationer must submit sample (s) at the time of submission of the quotation or one hour before opening of tender.
8. Subsidy will be given for a period covering full utilization of Rs. 24,15,600/- (subsidy money) only.
9. All documents for the quotation should be sealed in a an envelope addressed to the Secretary, NLUP Implementing Board, Opposite Raj Bhavan, Aizawl, Mizoram and superscribed in bold letters "QUOTATION FOR SUPPLY OF PIG FEEDS".
10. Only the documents sealed inside the submitted envelope will be considered while opening the tender.
11. Any document submitted after the stipulated date and time will not be entertained in any manner.
12. Rate should be quoted both in figures and in word. Over-writing, if any, should be initialed with date, otherwise the quotation will automatically be invalid.
13. Total amount to be supplied under subsidy will be Rs. 24,15,600/- only.
14. The NLUP Implementing Board reserves the right to revoke or cancel any supply order issued by the Department in part or whole without serving any notice.

15. The NLUP Implementing Board reserves the right to reject any of the quotation or all the quotations without giving any reason.
16. The NLUP Implementing Board reserves the right to select any rates quoted by the quotationers depending on quality of feeds offered.
17. The NLUP Implementing Board is not bound to select the lowest quoted rate as legal right. Selection will be affected by both samples and rate submitted by the quotationers.
18. Delay in payment, if any, of the bill will bear no interest in all cases.
19. The quotationers or their representative can be present at the time of opening of the quotation, if desired.
20. Any dispute or legal problem that may arise in this matter should be settled in Aizawl only.
21. Each quotation should be accompanied by an earnest money in call deposit at 2(two) percent of the total quoted amount.
22. Only the firms who are authorized dealers in pig feed will be considered for supplying the pig feeds.
23. NLUP Implementing Board shall have final authority to settle any dispute and shall have the final say in interpretation of any issue.
24. The actual amount (in Kg) of Starter and Finisher Feeds will be as per requirement of the PMCs from time to time.
