**TENDER NOTICE**

Sealed Tenders are hereby invited on behalf of the Chairman, State Health Society, Mizoram from reputed and bonafide Manufacturers or their authorized dealers who have Mizoram VAT Registration for **supply of Glucostrips under NPHCE** which will be received by the Mission Director, National Health Mission, Mizoram, on or before **31.8.2013, upto 12:00 PM** under the terms and conditions laid down below. Quotations are to be opened by MD NHM, Mizoram, Aizawl or his authorized representatives at **1:00 PM** on the same day. The Tenderers or their representative may also be present at the time of opening of the Quotations, if they so desire.

**TERMS & CONDITIONS**

1. Tenders submitted by Authorized dealers shall attach Authorization or Distributorship or Dealership (as the case may be) certificates from the concerned Manufacturers. A Gazetted Officer or Notary, however, shall duly attest Photo copy. Original Certificate shall be produced at the time of opening, if demanded.
2. The rate should be quoted as per the technical specifications to be offered by the Mizoram state Health society against the equipments/goods to be quoted. The tenderer should also clearly mentioned the free Glucometer and Lancets offered if any.
3. The technical and Financial Bid shall be submitted separately.
4. Tenders shall be submitted in the prescribed form only. A soft copy of prescribed form can be obtained from State NCD Cell, H&FW Dept. and shall be submitted along with the hard copy.
5. Earnest Money amounting to Rs. 10,000/- (Rupees ten thousand) only in the form of Bank Draft, from any Nationalized Bank of India or Postal Saving Certificate duly pledged in favour of Mission Director, National Health Mission, Mizoram, Aizawl must accompany such tender.
6. The cover of the tenders shall be superscribed as “**supply of Glucostrips under NPHCE**” addressed to Mission Director, National Health Mission, Mizoram, Aizawl clearly indicating full postal address of the tenderer/sender.
7. Non-tribal tenderer shall affix a Non- Judicial Court Fee Stamp worth at least Rs.7.50/- and shall furnish photo copy of MVAT Registration Certificate and MVAT Clearance Certificate up to the latest year for which assessment has been made by the concerned authority and duly attested by a Gazetted Officer or Notary. Original Certificates shall be produced at the time of opening, if demanded.

8. The tribal tenderer shall furnish attested copy of Tribal Certificate, MVAT Registration Certificate and MVAT Clearance Certificate up to the latest year for which assessment has been made by the concerned authority and duly attested by a Gazetted Officer or Notary. Original Certificates shall be produced at the time of opening, if demanded.
9. Manufacturers submitting their tenders directly shall attach photo copies of their Manufacturing Licence, CIN (Corporate Identity Number) and other relevant permissions/licences required for such manufacturing, duly attested by a Gazetted Officer or Notary. Original Certificates shall be produced at the time of opening of the tenders, if demanded.
10. Tenderer shall quote their rates in terms of Indian Rupees.
11. Rate shall be quoted inclusive of all taxes and duties and also clearly mentioned in the quotation.
12. F.O.R Destination shall clearly be mentioned.
13. All pages of the tender papers shall be printed, signed, stamped and dated; hand written quotations shall not be entertained. Any page or pages not signed, stamped and dated are liable to be rejected. Correction, if any, shall be initialed, stamped and dated.
14. If any tenderer violates or fails to fulfill any one of the clauses, his or her tender are liable to be rejected at the time of opening the tender.
15. Once the rate is accepted and communicated to the successful firm, the same will remain valid during the validity period of the agreement with the approved supplier and no price escalation will be permissible during the validity period, which is normally for a period of 12 months and is extendable, if mutually agreed upon by both the parties i.e. the Health & Family Welfare Department and concerned approved supplier, subject to recommendation to the Purchase Committee of Mizoram State Health Society.
16. A successful tenderer whose tender has been accepted shall execute an appropriate Deed of Agreement within 15 (fifteen) days from the date of communication of acceptance of his/her quoted rate(s) by fax, failing which their tender will be treated as invalid.
17. A successful firm shall supply the materials within the period fixed by the Department/Authority. If the supply cannot be accomplished within the stipulated period without any intimation, the Department has the right to procure the materials from any other sources and the differences in prices, if any, will be realized from the Security Deposit of the approved supplier, as mentioned herein, without assigning any reason thereof.
18. A successful firm will have to furnish Security Deposit of 5% of the value of the supply before issue of supply order in the form of Demand Draft/Fixed Deposit in any Nationalized Bank of India or Postal Saving Certificate, as the case may be, duly pledged in favor of Mission Director, National Health Mission, Mizoram
19. In case of any legal dispute/litigations arising out of this Tender Notice or its terms, the local courts shall have the jurisdiction as per the relevant laws in force.
20. Payments will be made only after the materials are received in full and in good condition to be certified by the Competent authority and after completion of the installation

satisfactorily at the representative destination whatever it is required so. There shall not be any advance payment and no such request shall be entertained.

21. Any attempt for negotiation/campaign, direct or indirect, on the part of a tenderer with the authority to whom he has submitted the Tender or the authority who is competent to accept the same, shall render such Tender liable to be excluded from consideration, if it is so proved.
22. Belated/delayed tenders shall not be entertained in any case. Certificates other than those stated in the foregoing clauses shall be rejected straightaway. Any other/further clarifications in connection with submission of tender mentioned herein may be made from the office of Mission Director, National Health Mission, Mizoram, Aizawl during office hours on all working days.
23. A successful tenderer shall have to supply the Goods to State NCD Cell, Department of Health & family Welfare, Dintar, Aizawl Mizoram at his own risk and responsibility and in good condition all respects.
24. Incomplete tender not in conformity with the terms and conditions as in this tender notice will be rejected outright.
25. Decision of the Purchase Committee of the Society shall be final and binding in all cases.
