Conditions for Contractor/firm :

Tender will be issued to eligible P.W.D. contractors, as well as non P.W.D. contractors provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below :-

Three similar work each of value not less than 40% of tendered amount or two similar work each of value not less than 60% of tendered amount or one similar work of value not less than 80% of tendered amount in last five years ending last day of the month previous to the one in which the tenders are invited.

Earnest money should be deposited along with the tender documents in separate envelope marked as "Earnest Money" in receipt Treasury Challan/deposit at call receipt of a scheduled Bank/fixed Deposit of Scheduled Bank/Demand Draft of a Scheduled Bank issued in favour of Chief Engineer, PWD., Buildings, Aizawl. A part of earnest money is acceptable in the form of Bank Guarantee also. In such case, 50% of earnest money of Rs. 20 lakh, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee valid for a period of six months or more from the date of submission of the tender.

50% concession will be available to all SC/ST bidders on production and submission of original/attested copy of SC/ST certificate in respect of Bid Security.

Both sealed envelopes (EMD and tender Document) marked as Earnest Money and Tender shall be submitted together in another sealed envelope superscripted with names of work and date of opening. The envelope marked tender shall be opened whose Earnest Money, placed in the other envelope mark as Earnest Money is found in order.
