1. Tenders should be super scribed on the cover as “**SHORT TENDERS FOR SUPPLY OF MICRONUTRIENTS**” addressed to the Director of Agriculture (Crop Husbandry), Aizawl, Mizoram. Name and address of the tenderers should be clearly indicated on the cover.
2. Tenders should be accompanied by earnest money amounting to Rs. 4000/- (Rupees four thousand)only in the form of Deposit at Call / Bankers Cheque in original from any Branch of Nationalized Bank duly pledged in favour of the Director of Agriculture, Crop Husbandry, Mizoram, Aizawl. Earnest Money thus deposited by unsuccessful tenderers will be released on request in writing only after selection of successful tenderers.

The Tribal Tenderers should furnish Photostat copy of Tribal Certificate, Valid Professional Tax Clearance Certificate, VAT Clearance Certificate, House Tax Payee Certificate & valid Fertilizer Dealership Licence Certificate duly attested by the Gazetted Officer or Notary. Original Certificate should be produced at the time of opening of the Tender.
4. Photo copy of valid of Form 'O' (Certificate of source) duly attested by Gazetted Officer/Notary should be enclosed. Original Certificate should be produced at the time of opening of tenders..
