Bidding documents should be downloaded from the internet site <https://www.morth.eproc.in> Cost of Bidding Document is Rs 6500/- (Rupees six thousand five hundred) only (non-refundable) in the form of Demand Draft/Bankers Cheque drawn in favour of Chief Engineer, PWD, Building and payable at Aizawl which shall be submitted by 12:00 noon on 15.11.2016.
3. Bids will be opened at 1300 hrs on 15.11.2016 in the office of Chief Engineer, PWD, Building. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
4. Bid documents consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can be seen in the office of the Chief Engineer, PWD, Building between hours of 9:00 A.M. and 5:00 P.M. on any working day between 14.10.2016 to 11.11.2016. The tender documents can be downloaded from the Internet at <https://www.morth.eproc.in> on payment by demand draft drawn in favour of Chief Engineer, PWD, Building and payable at Aizawl for Rs. 6500/- (Rupees six thousand five hundred) only (non-refundable) for each package..
5. Pre-Bid Meeting will be held on 25<sup>th</sup> October 2016 at 1300 hrs at the office Chamber of Chief Engineer, PWD, Building Tuikhuahtlang, Aizawl.
6. Bid must be submitted through <http://morth.eproc.in>. Submission of Bid will be closed on 1200 hours on 25.11.2016.
7. Earnest money/ Bid Security of the amount specified for the work in the table should be submitted along with the 'Cost of Bidding Document'. The earnest money will have to be in any one of the forms as specified in the bidding documents.
8. The bid for the work shall remain open for acceptance for a period of ninety days from the date of opening of bids. If any bidder/ tenderer withdraws his bid/ tender before the said period or makes

any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.

9. A bidder shall not be permitted to bid for works in the Circle responsible for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive).
10. No Engineer of gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.
11. Uploaded documents should be clear and readable. Unreadable documents will not be entertained.
