2. Joint ventures are not accepted. Contractors who fulfill the following requirements shall be eligible to apply:
- Should have satisfactorily completed the works as mentioned below during the last seven years ending previous day of last date of submission of tenders.
    - Three similar works each costing not less than ₹444.00 lakh or two similar works each costing not less than ₹666.00 lakh one similar work costing not less than ₹888.00 lakh.
  - Should have had average annual financial turnover of ₹666.00 lakh on construction works during the last three years ending 31st March, 2017
  - Should not have incurred any loss in more than two years during the last five years ending 31st March 2017
  - Should have a solvency of ₹444.00 lakh.
3. Bid documents consisting of plans, specifications, the schedule of quantities of the various types of work to be done and the set of terms and conditions of contract to be complied with the contractor whose bid may be accepted and other necessary documents can be seen and purchased in the office of the Chief Engineer, PWD, Buildings during office hours upto **7<sup>th</sup> July 2017** every day except on Saturday, Sunday and Public Holidays. Bid documents, including standard form will be issued from his office, during the hours specified above, on payment ₹2500.00 as cost of bid document.
4. Applicant has to deposit Earnest Money of ₹22,19,993.14 for Non-tribal and ₹11,09,996.57 for Tribal in the form of Receipt/Treasury Challan/ Deposit at call receipt of a schedule bank/fixed deposit receipt of a schedule bank/demand draft of a scheduled bank issued in favour of Chief Engineer, PWD, Buildings along with tender document. A part of Earnest money is acceptable in the form of Bank Guarantee also. In such case, 50% of earnest money or Rs. 20 lakh whichever is less will have to be deposited in shape prescribed above and balance in shape of Bank Guarantee.

5. The bids will be received up to **12:00 Noon on 10<sup>th</sup> July 2017**. The envelopes Marked "Eligibility Documents" shall be opened by the Chief Engineer, PWD, Buildings or his authorized representative in his office on the **same day at 1:00 PM**.

(i) Pre Bid conference shall be held in the office chamber of Chief Engineer, PWD, Buildings at **12:00 Noon on 3<sup>rd</sup> July 2017** to clear the doubt of intending tenderers, if any.




