# Bidding Document for Supply and Installation of IPDS Sign Board in Mizoram

## **PART – A** SECTION – 1 : INTRODUCTION

#### 1.0 : <u>SCOPE OF WORK</u>

- 1.1: Power & Electricity Department is the Project Implementing Agency (PIA) to implement Integrated Power Development Scheme (IPDS) in Mizoram. The scheme is funded by Ministry of Power, Govt. of India through Power Finance Corporation Ltd. As per the scheme guideline, IPDS Signboard has to be displayed in IPDS towns.
- 1.2: The 6 towns where signboards are to be displayed are Mamit, Vairengte, Kawnpui, Khawhai, Thenzawl, Hnahthial. 2 nos in each town (English & Hindi) totaling 12 nos.

## **SECTION – 2 : INSTRUCTION TO BIDDERS**

#### 1.0 : GENERAL INSTRUCTIONS

The Engineer-in-Chief, Power & Electricity Department, Government of Mizoram, hereinafter called the Department or Owner will receive bids in respect of supply and erection of IPDS signboard as set forth in the accompanying specifications.

#### 2.0 : QUALIFYING REQUIREMENT OF BIDDERS

- 2.1 : The bidders can be any person who acquired knowledge and have expertise in hoarding or signboard
- 2.2 : The bidder must be reputed firm to deal with the captioned work.

#### **3.0 : COST OF BIDDING**

3.1 : The bidder shall bear all costs and expenses associated with preparation and submission of its bid including post-bid discussions, technical and other presentations etc., and the Department will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

#### 3.2 : UNDERSTANDING BID DOCUMENT

A prospective bidder is expected to examine all instructions, forms, terms and specifications in the Bid documents and fully inform himself as to all the conditions and matters which may in any way affect the scope of work or the cost thereof. If the prospective Bidder finds discrepancies or omissions, in specifications and document or is in doubt as to the true meaning of any part, he shall at once make a request, in writing, for an interpretation / clarification, to the Owner. The Owner, then, will issue interpretation(s) and clarification(s) as he may think fit in writing. After receipt of such interpretation(s) and clarification(s), the Bidder may submit his bid but within the time and date as specified in the Invitation to Bid.

#### 3.3 : SCOPE OF THE PROPOSAL

The scope of the Proposal shall be on the basis of a single Bidder's responsibility, completely covering all the requisite work specified under the accompanying technical specifications. It will include the followings:

- a) Fabrication of signboard as per technical specifications.
- b) Portraying and writing specified script/ emblem.

c) Supply and installation of the finished product at all the villages covered under Bid document.

3.4 : Bids not covering the above entire scope of Works shall be treated as incomplete and hence liable to be rejected.

#### 4.0 : BID PRICE/ PRICE NORMS

- 4.1 : The bidder shall quote in the appropriate schedule of Bid form for the entire scope of works (covered under the Bidding Document).
- 4.2 : The Bidder shall furnish the price Bid in the appropriate schedule which will include all charges towards MVAT, loading, unloading, erection and any other statutory levies payable by the bidder.
- 4.3 : Bidder shall indicate bid prices in Indian Rupees only.

#### 5.0 : TAXES AND DUTIES

All statutory levies payable by the Bidders in respect of the transaction between the Bidder and their vendors/sub-contractor while procuring any components, sub-assemblies, raw materials etc shall be included in the Bid price and no separate claim on this behalf will be entertained by the Department.

#### 6.0 : TIME SCHEDULE

Supply and installation of Signboards complete with supporting structure, etc. will have to be completed one month from the date of issue of Work Order (LOA).

#### 7.0 : SUBMISION OF BIDS

- 7.1 : The Bidder shall prepare 2 (two) copies of the bid document, clearly marking "Original" and "Duplicate' respectively.
- 7.2 : The original and Duplicate copies of the bid shall be typed in A4 size paper and shall be signed by the Bidder.
- 7.3 : The bid shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the Bidder, in which case such corrections shall be initialed by the person or persons signing the bid.
- 7.4 : The bid must contain the name, residence and place of business of the person or persons making the bid and must be signed and sealed by the Bidder with his usual signature. The names of all persons signing should also be typed or printed below the signature.
- 7.5 : The Bidder's name stated on the Proposal shall be exact legal name of the firm/ person.
- 7.6 : Bids not conforming to the above requirements of signing shall be disqualified.

- 7.7 : The Bidder shall seal the original and Duplicate copy of the Bid in separate envelopes duly marking the envelopes as 'Original' and 'Duplicate' and submit in separate sealed covers.
- 7.8 : The Bid shall be opened in presence of attending Bidders or their representatives.
- 7.9 : The envelopes shall be addressed to: **The Engineer-in-Chief, Power & Electricity Department, Kawlphetha, New Secretariat Complex, Khatla, Aizawl – 796001.**
- 7.10 : The Bidders have to submit the bid in person.
- 7.11 : Bid must be received by the Department at the address specified under para 7.9 above not later than the time and date mentioned in the invitation to bid.
- 7.12 : Any bid received by the Department after the time and date fixed or extended for submission of bids prescribed by the Department will be rejected and/ or returned unopened to the Bidder.
- 7.13 : The Bidder may modify or withdraw its bid after the bid's submission provided that written notice of the modification or withdrawal is received by the Deptt. prior to the deadline prescribed for submission of bids.
- 7.14 : No bid may be modified subsequent to the deadline for submission of bids.

#### 8.0 : BID OPENING AND BID EVALUATION

- 8.1 : The Department will open bids in the presence of Bidders and/or their representatives who are willing to attend at the date and time for opening of bid in the invitation to bid.
- 8.2 : To assist in the examination, evaluation and comparison of bids, the Department may, at its discretion, ask the Bidder for clarification of its bid. The request for clarification and the response shall be in writing and no change in the price or substance of the bid shall be sought, offered or permitted.
- 8.3 : The Department will examine the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed, and whether the bids are generally in order.

#### 9.0 : CONTACTING THE P&E DEPARTMENT

Bids shall be deemed to be under consideration immediately after they are opened and until such time official intimation of award/rejection is made by the P&E Department to the Bidders. While the bids are under consideration, Bidders and/or their representatives or other interested parties are advised to refrain from contacting by any means, the P&E Department and/or his employees/representatives on matters related to the bids under consideration. The P&E Department, if necessary, will obtain clarifications on the bids by requesting for such information from any or all the Bidders, either in writing or through personal contacts as may be necessary. Bidders will not be permitted to change the substance of the bids after the bids have been opened.

#### 10.0 : RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

The P&E Department reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the P&E Department action.

## SECTION – 3 : GENERAL CONDITIONS OF CONTRACT (GCC)

#### **1.0 : DEFINITION OF TERMS**

- 1.1 : 'The Contract' means the agreement entered into between P&E Department and Contractors as per the contract agreement signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.2 : Power & Electricity Department, Govt. of Mizoram shall include their legal representatives, successors and assignees.
- 1.3 : 'Contractor' shall mean the Bidder whose bid will be accepted by the P&E Department for award of the work and shall include such successful Bidder's legal representative's successors and permitted assignees.
- 1.4 : 'Engineer' shall mean the officer appointed by the P&E Department to act as Engineer from time to time for the purpose of the Contract.
- 1.5 : 'Specifications' shall mean the specifications and Bidding Documents forming a part of the contract and such other schedules and drawings as may be mutually agreed upon.
- 1.6 : 'Date of Contract' shall mean the calendar month. 'Day' or 'Days', unless herein otherwise expressly defined, shall mean calendar day or days of 24 hours each.
- 1.7 : 'Writing' shall include any manuscript, type written or printed statement, under or over signature and/or seal as the case may be.

#### 2.0 : LANGUAGE AND MEASURES

All documents pertaining to the contract including specification, schedules, notice, correspondence, operating and maintenance instruction, drawings or any other writing shall be written in English language.

#### **3.0 : GUARANTEE**

- 3.1 : The contractor shall warrant that the equipments will be new, unused and in accordance with the contract documents and free from defects in material and workmanship for a period of 12 (twelve) calendar months commencing immediately upon the satisfactory supply & erection.
- 3.2 : If it becomes necessary for the contractor to replace or renew any defective supplied materials, the provision of this clause shall apply to the materials so

replaced or renewed until the expiry of 12 (twelve) months from the date of such replacement or renewal.

#### 4.0 : DEFENCE OF SUITS

If any action in court is brought against the P&E Department or Engineer or an officer or agent of the P&E Department, for the failure, omission or neglect on the part of the contractor to perform any acts, matters, covenants or things under the contract, or for damage or injury caused by the alleged omission or negligence on the part of the contractor, his agents, representatives or his sub-contractors, or in connection with any claim based on lawful demands of sub-contractors, workmen, suppliers or employees, the contractor shall in all such cases indemnify and keep the owner, and the engineer and/ or his representative, harmless from all losses, damages, expenses or decrees arising of such action.

#### 4.1 : ENGINEER'S DECISION

The Engineer's decision and the filing of the written objection thereto shall be a condition precedent to the right to request arbitration. It is the intent of the agreement that there shall be no delay in the execution of the works and the decision of the Engineer as rendered shall be promptly observed.

#### 5.0 : PAYMENT

- 5.1 : 100% payment shall be made after receipt of bills duly verified and passed by the concerned SDO and EE respectively subject to availability of fund in the relevant Head of Account. The bills must be accompanied by photographs of the signboards ( one hard copy accompanied by soft copy).
- 5.2 : Paying authority : Engineer-in-Chief, Power & Electricity Department.

#### 6.0 : **RESOLUTION OF DISPUTES**

- 6.1 : Any dispute(s) or difference(s) arising out of or in connection with the Contract shall, to the extent possible, be settled amicably between the parties.
- 6.2 : If any dispute or difference of any kind whatsoever shall arise between the Owner and the Contractor, arising out of the contract for the performance of the works whether during the progress of the Works or after its completion or whether before or after the termination, abandonment or breach of the Contract, it shall, in the first place, be referred to and settled by the Engineer, who, within a period of fifteen (15) days after being requested by either party to do so, shall give written notice of his decision to the Deptt. and the Contractor.

- 6.3 : All disputes or difference in respect of which the decision, if any, of the Engineer has not become final or binding as aforesaid shall be settled by arbitration in the manner hereinafter provided.
- 6.4 : During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out their respective obligations under the Contract.

## SECTION – 4 : SPECIAL CONDITION OF CONTRACT (SCC)

#### 1.0 : EARNEST MONEY

- 1.1 : All bids must be accompanied by Earnest money of Rs. 4170.00 (Rupees Four thousand one hundred seventy only) i.e 2% of the estimate cost through Demand Draft (DD) of scheduled Bank drawn in favour of Engineer-in-Chief, Power & Electricity Department.
- 1.2 : The Earnest Money will be regulated as per the relevant clause of CPWD Works Manual as and when the need arises.

#### 2.0 : **PERFORMANCE SECURITY**

2.1 : The successful bidder/contractor shall deposit an amount equal to 5% of the accepted value of the work as Performance Guarantee in an irrevocable Bank Guarantee in favor of Engineer-in-Chief, Power & Electricity Department.

#### **3.0 : FINALISATION OF BID**

3.1 : The bids received from the eligible firm will be evaluated and comparative statement will be prepared for consideration and approval of the competent authority. The selecting criteria for the successful bidder will be at the discretion of the competent authority in the best interest of the work.


