TERMS AND CONDITIONS

1. The Vehicle can be inspected by interested persons in the office premises of FSL during office hours.
2. The sale of vehicle shall be strictly on '*as-is-where-is basis*' and no guarantee or certificate of its worthiness or quality be given by the FSL.
3. The bidder should furnish a bid security equivalent to 10% of the reserved price. The exact bid security amount should be indicated in the bidding document.
4. Bid security shall be in the form of a Deposit-at-Call pledged in favour of the Director, FSL, Mizoram, Aizawl.
5. The Quotationer should submit the original EMD with the Auction ID number mentioned in the portal in sealed envelope and addressed to the Director, Forensic Science Laboratory, Mizoram Aizawl and the words "Quotation for purchase of condemned vehicle No. MZ01 C 4818" shall be super scribed.
6. Quotation should be submitted through GeM e-Auction (online mode) only.
7. Quotation without earnest money will be summarily rejected.
8. FSL is not bound to accept the highest bid. The successful bidder should deposit full amount of the bid within 3 (Three) days (office working day) of the auction day, failing which his/her quotation will be rejected.



11. Successful quotationer must remove the vehicle within 5 days after issue of release order. In case he/she fails to remove the vehicle within stipulated time, rent of Rs. 100/- per day will be charged.
