TERMS AND CONDITIONS/AGREEMENT FOR EXTRACTION/COLLECTION OF BROOMSTICK THROUGH AUCTION SALE UNDER THENZAWL FOREST DIVISION

- 1. Application for participation in auction, in the prescribed form duly completed in all respect and affixed with a non-refundable court fee stamp worth Rs.10/- (Rupees ten only) along with requisite documents should be submitted the Divisional Forest Officer, Thenzawl latest by 10:30 am on 11.11.2022. In case of ST /SC /OBCs, no court fee stamp will be required but the applicant shall enclose an attested copy of House Tax Payee Certificate (HTPC). The prescribed application form can be collected from the Office of the undersigned on payment of Rs.50/ (Rupees fifty only) during office hours on all working days.
- 2. The Applicant should sign (with date) the declaration appended at the bottom of the application form.
- 3. There is no obligation on part of the undersigned to make sale or to accept the highest bid and the undersigned reserves the right to accept or reject any bid without assigning any reason.
- 4. The application form shall be accompanied by the following documents:
- a) An upto date Income Tax Clearance Certificate for Non-Mizo's and Professional Tax Clearance Certificate for Mizo applicants (duly attested by a Gazetted Officer with official seal, in case of Xerox/photo copies of such documents).
- b) Sales Tax/VAT Clearance Certificate (if applicable).
- c) If the applicant is a non-Mizo person belonging to any of the ST, SC or OBC recognized in the State of Mizoram, then in addition to the requirement () and (1i) above, the original Social Status Certificate or copy of the same attested by a Gazetted Officer in support of his claim to belong to such community from the competent authority.
- d) Three specimen signature of the applicant duly attested by a Gazetted Officer with full name, designation and seal.
 - e) The undersigned may call for any other particulars/documents from any applicant for identifying him/her and/or for verifying his/her financial soundness, before Accepting or rejecting application.
 - f) Signed declaration as prescribed in the application form.
 - g) Passport size photograph of the applicant duly attested by any Gazetted Officer with his official seal, to be pasted/ affixed in the application form.
 - h) Any application not accompanied by the above mentioned documents will be liable to rejection without giving any opportunity to the applicant to be heard on to explain.
 - 5. The period for collection of Broomstick shall be w.e.f. 01.12.2022 to 30.04.2023. All the extraction processes including transportation to final destination should be completed within the period mentioned above. Only Broomstick from the Forest areas and Non-Forest Government lands within the jurisdiction of Thenzawl Forest Division should be collected/extracted.

- 6. No extension of the working period will ordinarily be entertained and any extracted Broomstick lying in the forest which is not transported to the destination after the prescribed period of operation shall become the property of the Government. In exceptional circumstances, DFO, Thenzawl reserves the right of extension of the period on merit of each case at his discretion and on payment of charges as may deem fit.
- 7. Any excess collection of Broomstick beyond the stipulated quantity shall be sold on Permit system realizing royalty as per the standing Government notification /order. Broomstick system realizing royalty as per the standing Government notification /order. Broomstick illegally collected if any shall be seized and confiscated. The same may be released only after payment of penalty which shall be at least times the royalty as fixed by the State government.
- 8. The successful bidder shall make the payment of the bidded amount in full within fifteen (15)days counting from date of auction.
- 9. The successful bidder shall deposit security deposit which is 15 % of the amount offered by the successful bidder on the day of Auction sale. Failure of payment of security deposit and bidded amount within stipulated time shall result in cancellation of Auction and shall lead to re-auctioning.
- 10. The extraction of Broomstick will have to be done skilfully so that means of public transport and communication are not endangered/ disturbed in any way. The Mahalder shall be liable to make payment upto double the value of other Forest Produce as assessed by the Divisional Forest Officer/ Range Officer concerned if he/she is found to have damaged any such Forest Produce during the course of operation of Broomstick extraction.
- 11. The Mahalder/ Permit Holder will have to make his/her own arrangement for transportation of the auctioned materials from the sites including construction of approach road/ raft, collection house etc.
- 12. The Department shall not be responsible to make any arrangement for the protection and movement of the Contractor or his/her employees working in the area.
- 13. Transportation of the auctioned materials will be done only with Transit Pass to be issued by Range Officer concerned after necessary verification.
- 14. The Mahalder/Permit Holder shall have to work in conformity with the general directions of the Forest Officer in charge of the area during the entire process of extraction/collection.
 - 15. In case of any kind of dispute arise during the course of operation, the matter shall be referred to the State Government whose decision shall be final and binding on the parties thereto.
