- P&E Department will assist in signing of Power Purchase Agreement (PPA) between SPD and Government of Mizoram (GoM) and Power Sale agreement (PSA) subject to tariff approved by Joint Electricity Regulatory Commission (JERC for Manipur & Mizoram).
- P&E Department will assist the SPD for obtaining the permissions from Government of Mizoram for movement of workers.

#### **Bidders scope of work:**

- a. The main scope of the Bidder is to assess the potential of the Grid connected Solar Power Plant capacity at each location.
- b. The scope of the work also includes Design, Engineering, Manufacture, Supply, Erection, Testing and Commissioning of the Plants with Operation and Maintenance and the evacuation of the Power & its transmission up to injecting substation including construction of necessary Bays at P&E Department's nearest substation where solar power is to be generated.
- c. However, the projects would be technology agnostic within the technology approved by the MNRE i.e., crystalline silicon or thin film. Only commercially established and operational technologies can be used, to minimize the technology risk and to achieve the timely commissioning of the Projects.
- d. SPD will install suitable meters at solar power plant and injecting Grid substation where solar power generate is to be injected. Joint calibration should be done by P&ED and SPD initially and time to time.
