Sealed Tenders are hereby invited on behalf of the Governor of Mizoram from reputed and bonafide local manufacturers for **Tender for Rate Contract of Refilling of Medical Gases Cylinder** which will be received by the Director, Hospital & Medical Education, Mizoram, Aizawl, New Capital Complex or his authorized representatives on or before **17<sup>th</sup> March, 2023 upto 12:00 noon** under the terms and conditions laid down below. Quotations are to be opened by the Director, H&ME, Mizoram, Aizawl or his authorized representatives at **3:00 pm** on the same day. The tenderers or his/her representatives may also be present at the time of opening of the quotations of the tender, if so desire.

**TERMS & CONDITIONS**

1. Tenders should be submitted in Original only. The cover of the tenders should be super scribed as "**Tender for Rate Contract of Refilling of Medical Gases Cylinders**" addressed to the Director, Hospital & Medical Education, Govt. of Mizoram, Aizawl and should clearly mentioned full postal address of the tenderer.
2. Tenders should submit attested photo copy of their Manufacturing License. Original Certificate should be produced at the time of opening, if demanded.
3. Tenders should be submitted in prescribed form only.
4. Rates should be clearly mentioned by figure and word in Indian rupees only which must be inclusive with GST.
5. Tenders should submit attested photo copy of Tax Clearance Certificate or any related papers from the concerned authority.
6. Place of delivery of various refilled Medical gases cylinders should be at Civil Hospital, Aizawl and State Referral Hospital, Falkawn.
7. Additional charge (courier charge) for delivery of medical gases at District Hospital, Lawngtlai and Siaha should be quoted in separate sheet.
8. Earnest money should accompany tenders amounting to Rs. 8,000/- (Rupees eight thousand) only in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online in an acceptable form, safeguarding the purchaser's interest in all respects.
9. Tender must have accompanied by the following documents -
  - a) Copy of GST Registration.
  - b) Copy of Tribal Certificate for Tribal
  - c) Non-Tribal Tenderers' shall affix a Non-Judicial Adhesive stamp worth at least Rs. 7.50.
10. Tenders should attach Photo copy of Purity Certificate of Medical gases from the concerned authority up to the latest year for which assessment has been made by the concerned authority duly attested by a Gazetted Officer or Notary.

11. All pages of the tender papers should be printed, signed, stamp and dated. Any page or pages not signed, stamped and dated are liable to be rejected. Correction, if any, should be initialed, stamped and dated.
12. If any tenderer violates or fails to fulfill any one of the clauses, his or her tender should be marked or noted as *violated* clause at the time of opening the tender.
13. Once the rate is accepted, the validity of the period of approved rate of the tender will be one year from the date of deeds of agreements duly signed by both the approved supplier and the Director, Hospital & Medical Education, Mizoram, Aizawl and is extendable, as the case may be, subject to recommendation of State/Departmental Purchase Advisory Board. Any increase of rate on price escalation during the contract period will not be permissible unless under the direction of the competent authority.
14. A successful firm should furnish Security Deposit of Rs. 20,000/- (Rupees twenty thousand) only in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online in an acceptable form, safeguarding the purchaser's interest in all respects, as the case may be, duly pledged in favour of Director, Hospital & Medical Education, Government of Mizoram, Aizawl for 1 year and the deeds of agreement paper will be valid for a period of 2 years.
15. A successful firm should execute an appropriate Deeds of Agreement within 30 days from the date of issue of acceptance of their quoted rates failing which their quoted rate will be treated as invalid.
16. The undersigned shall not be bound to accept the lowest rate or any of the tenders and reserves the right to accept or reject any tenders without assigning any reason thereof.
17. In case of any legal disputes/litigations arising out of this Tender Notice or its terms, the Courts of Law at Aizawl only shall have jurisdiction to adjudicate the same.
18. Any tenderer communicates or transacts the authority or anyone else in order to compromise, negotiate for succession, quotation of his/her tender should be rejected.
