TERMS AND CONDITIONS FOR OUTSOURCING OF 7 (SEVEN) FOOD SAFETY OFFICERS UNDER DIRECTORATE OF HEALTH SERVICES

- All tenders should be submitted in the prescribed format given in FORM-A, which can be obtained at the Directorate of Health Services, MINECO, Khatla, Aizawl, or download at website https://health.mizoram.gov.in with a fee of Rs. 500/-.
- All Firms/ Agency should deposit 'Earnest Money' @ 3% of the fixed remuneration per head in the form of Call Deposit in any Nationalized bank in Mizoram in favor of "Director of Health Services, Mizoram; Aizawl".
- 3. The selected Firm/ Agency should made 'Security Deposit Money' @ 5% of the fixed remuneration per head in the form of Call Deposit in any Nationalized Bank in Mizoram in favor of "Director of Health Services, Mizoram; Aizawl".
- 4. The remuneration of the casual employees @ Rs. 50,000/- (Rupees fifty thousand) only per month for the period of 10 (ten) months fixed as per the Memorandum of Understanding between Food Safety and Standard Authority of India and The State of Mizoram for Strengthening of Food Safety Eco-system in the State/UT will be borne by the Directorate of Health Services, Mizoram; Aizawl which shall be disbursed by the selected firm/agency.
- 5. The recruiting agency may take commission charge not more than 10% of the total remuneration of the employee which shall be quoted at the time of submission of the sealed quotation and the commission charge will be borne by the Directorate of Health Services, Mizoram; Aizawl. The GST charge, if any, will also be borne by the Directorate of Health Services, Mizoram; Aizawl.
- All persons to be recruited by the registered Firms/ Agencies should have acquire all the
 qualifications for corresponding posts under the Government of Mizoram prescribed by
 the relevant approved Service Rules/ Recruitment Rules framed by Government of
 Mizoram (see Annexure).
- 7. All the intending Firms Agencies should fulfill the following criteria:
 - Must be a citizen of India.
 - ii) Should furnish GST clearance as per the GST Rules.
 - iii) Must be Scheduled Caste/ Tribe (Caste Certificate to be enclosed)
 - iv) Must have Registration Certificate from Firms & Societies, Mizoram.
 - Must not have any criminal case (Certificate of proof from the concerned Police Station be enclosed).
 - vi) Must be financially sound to take up the task (financial soundness certificate to that effect from the Bank where the applicant has an account should be furnished).

- 8. The recruiting Agency will be responsible for the conduct and performance of the employee. In the event of misconduct or damage caused by the employee resulting in loss of the Government property, the Director of Health Services will report to the recruiting Firm/Agency for taking appropriate action as deemed fit.
- Selection of Firm/ Agency for outsourcing of manpower will be made by the Directorate of Health Services from the Firms/ Agencies which submitted sealed quotation within the prescribed period.
- 10. If the selected Firm/ Agency fails to supply manpower within the stipulated period or if it fails to continue the provision of manpower at any time during the term of the contract agreement, the Security Deposit made by the Firm/ Agency shall be forfeited to the Government as revenue and such Film/Agency may be declared as 'Defaulter' for a minimum period of 3 (three) months that may cause ineligibility to enter into any agreement with the Government for the suspension period.
- 11. A deed of agreement in a non-judicial stamp worth not less than Rs. 50/- (Rupees fifty) only shall be signed by the Directorate of Health Services on the first part and the recruiting Film/ Agency on the second part in line of the format appended in FORM-B of the 'Mizoram Guidelines for Outsourcing of Manpower, 2022'.
- 12. The Work Distribution, Daily Duty Details, Work Evaluation and Monitoring of the casual employees will also be observed and monitored by the authority of the Directorate of Health Services from time to time.
- 13. Release of 'Earnest Money Deposit' and 'Security Deposit':
 - (a) The Earnest Money Deposited by the unsuccessful Firms/ Agencies may be released after the selected Firm/ Agency deposit Security Deposit and also signs an agreement with the Department.
 - (b) The Security Deposit made by the selected Firm/ Agency may be released after satisfactory' completion of the contract.
