The Bid document including standard GCC will be issued on payment Rs.1000.00 as cost of bid document.
4. Applicant has to deposit Earnest Money of Rs. 24,000.00 for Non-tribal and Rs. 12,000.00 for Tribal in the form of Demand Draft or Deposit at call receipt of a schedule bank in favour of Executive Engineer, Health & Family Welfare Department, Mizoram, Aizawl along with tender document.
5. No Pre-Bid meeting shall be held, but all doubts and proposals regarding this tender, if any, shall be entertained in the office chamber of Executive Engineer, Health & Family Welfare Department, Mizoram, Aizawl during office hours to clear the doubts of intending tenderers.
