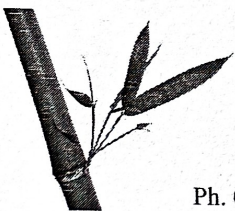

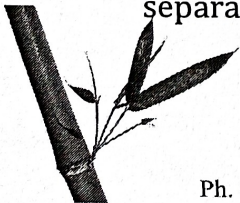

TERMS AND CONDITIONS

1. Submission of tender:
 - 1.1 Quotation should be addressed to the Executive Director, Bamboo Development Agency, Directorate of commerce and industries, Khatla Aizawl, Mizoram – 796001.
 - 1.2 Quotation should accompanied by the following documents and certificate.
 - a) A copy of GST Registration Certificate
 - b) Other documents like: factory registration, ITR PAN etc.
 - 1.3 Quotation should be superscribed on the cover as **“QUOTATION FOR SUPPLY OF BAMBOO MACHINERIES”**.
2. Rates of each item should be quoted both in figures and words. All corrections must be initialed and dated. No over writing is permitted. Rates for each item quoted must be included all taxes.
3. Quotation should separately show transportation and transit insurance, training and GST should be applied in total.
4. Rate should be quoted inclusive of GST per unit basis for Aizawl.
5. Quotation should enclose with their authorized dealership certificate for each Product /company quoted.
6. Quotations should clearly in their quotation specifications like the type, brand name, make, model, and the name of the manufacturer etc. should be given for all the quoted items.
7. Revisions of rates during the period of validity of quoted either from the government or company will not be entertained in any cases.
8. The quotation must submit a sample or catalogue for each item at the time of submission of the quotation or one hour before opening the quotation.
9. Reasonable rates for installation and training of all machines should be quoted separately.

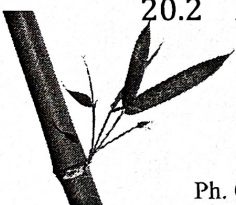

10. Any material found defect, incomplete, below the mark, brand and company not specified in the supply order, damaged, unserviceable will be summarily rejected. The Agency will not be responsible for rejected machinery in case of theft, lost or damage. Removal of rejected items will be solely responsibility of the supplier and will be replaced without extra cost by the supplier.
11. Warranty period should be indicated in the quotation.
12. Any dispute or legal problems arise in this matter should be settled at Aizawl jurisdiction only.
13. The Executive Director, Bamboo Development Agency reserves the right to revoke or cancel any supply order issued by the department in part or whole without serving any notice.
14. The Executive Director, Bamboo Development Agency reserves the right to reject any of the quotation or all the quotations without giving any reasons thereof.
15. The Executive Director, Bamboo Development Agency reserves the right to select any rates quoted by the quotationers depending on quality of machinery offered.
16. The Executive Director, Bamboo Development Agency is not bound to select the lowest quoted rate as legal right. Selection will be affected by both samples or catalogue and rate submitted by the quotationer.
17. Delay in payment of the bill bear no interest in all cases.
18. The quotationer or his representative can be present at the time of opening of the quotation if desired.

 - 20.1 Payment shall be made only after delivery and acceptance of the materials which must be countersigned by the officer in charge of the BDA.
 - 20.2 No advance payment will be made in any case.



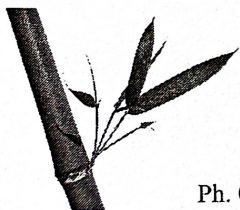
