TENDER NOTICE

In pursuance of the Government approval vide No. F.16013/1/2001-HM(HG) dt. 13.06.2024 Sealed Tender on plain paper is hereby invited from manufactures/dealers/registered firms/approved agents for supply of Personal Clothing/Equipment/Stores/Uniforms for Mizoram Home Guards & Civil Defence Department (MRHG&CD) for the year 2024-2025. Tenders will be received upto 01.08.2024 and will be opened on the same day at 01:00 P.M at MRHG&CD, Headquarters Hall, Chawlhhmun, Aizawl. Details of the tender can be had from the office of the undersigned on any working day during office hours.

TERMS AND CONDITIONS

1. The tender should be subscribed on the cover as 'Tender for Supply of Personal Clothing/ Equipment /Stores/Uniforms' written clearly in block letters. It should be addressed to the Commandant General-cum-Director, MRHG & CD, Aizawl, Mizoram.
2. 2% of the estimated/total value of the tender quantity, calculated at the rate tendered should be deposited by tenderers to any bank recognized by the Government of Mizoram as bid security/earnest money in the form of Account Payee Demand Draft, Fixed Deposited Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online in an acceptable form deposited at call duly pledge in favour of the Commandant General-cum-Director and the same should be submitted alongwith the tender.
3. The tenderers must submit their respective samples of all items alongwith the tenderer's name clearly marked and sealed. Tenderers can also submit alternative designs/samples for selection. 'Trade Mark' is to be mentioned clearly otherwise the tender will be liable for rejection. All selected samples will kept by Commandant General-cum-Director as Master Samples.
4. The selected tenderers must complete the supply of the required articles within a period of ninety (90) days from the date of placing formal supply order.
5. The undersigned is not bound to accept the lowest quotes and may reject any tender without assigning any reason thereof.
6. Tender once submitted will be final. Rate must be for Aizawl inclusive of sales and other applicable taxes including cost of transportation, etc. The rate quoted by the tenders will remain in force for a period 1 (one) year from the date of acceptance of the tender. It will be binding on the part of the tenderers to supply the article at the quoted rates. Rates must be quoted both in figures and in words.
7. In the event of any manufacturing defect/sub-standard item being supplied, the Commandant General-cum-Director, Mizoram Home Guards & Civil Defence will reserve the right to purchase substitute items of the approved quality at the expense of the Contractor. The security deposit will be returned to the contractor on completion of the supply and being satisfied that no manufacturing defects/sub-standard has been detected.

8. All suits including claim for damages or disputes arising out of this contract shall be deducted at Aizawl, Mizoram only.


