#### Creation Of Geo-Database for Lunglei town in Mizoram

#### 1. Introduction

- 1.1 On 25 June 2015, the Hon'ble Prime Minister, had launched the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for 500 cities. Thereafter, as a mandatory reform under the AMRUT Mission a 'Sub-Scheme on Formulation of GIS-based Master Plan for AMRUT cities' was launched by the Ministry of Housing and Urban Affairs (MoHUA) with 100% Central funding. This Sub-Scheme targeted Metro and Class I towns of India.
- 1.2 In continuation to the above, the Hon'ble Prime Minister of India launched the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 on October 1, 2021. As per Reforms/Milestone no. 13 at Annexure 5 of AMRUT 2.0 Guidelines, a Sub-Scheme for 'Formulation of GIS-based Master Plans of Class-II Towns with a population of 50,000 99,999' has been designed and approved by MoHUA.
- 1.3 The AMRUT 2.0 GIS Sub Scheme comprises of five components i.e., Geodatabase creation, Formulation of GIS-based Master Plans, Capacity Building, Development of National Urban Geo-portal and Development of Integrated Mobile Application. While the first three components will be implemented by the State directly, the latter two components will be developed by MoHUA and have to be put into usage by the States.
- 1.4 In this regard, Town & Country Planning Wing (TCP), UD&PA Department is the State Nodal Agency (SNA) in coordination with AMRUT State Mission Directorate for implementing the AMRUT 2.0 GIS Sub-Scheme in Mizoram State. TCP, has intended to hire world class GIS experts and urban planners to formulate GIS-based Master plan for Lunglei Town using GIS and Drone/ UAV technology. Geodatabase creation shall cover the planning area as given below:

# 1.5 Description of the Assignment/Project

The major component of the assignment is 'Creation of Geo-Database'. GIS-based base maps shall be created at the functional scales and defined layers as per Design & Standards documents of 'Sub-Scheme on Formulation of GIS based Master Plan for AMRUT Cities' and 'Application of Drone Technology for Formulation of GIS based Master Plan for Small and Medium Towns' published by Ministry of Housing and Urban Affairs (MoHUA) in October, 2020.



#### 2. Scope of Work

- **2.1** Geo-Database Creation and Updating of Geospatial Data, but not limited to the following aspects:
  - i. Drone Survey may be used for creation of base map for Lunglei Planning area of 94.7 Sq.km.
  - ii. DGPS Survey
- iii. Image Processing for digitization
- iv. Digitization of Base Map
- v. The base map shall contain all key physical features mentioned in Design & Standards for Design & Standards documents of 'Sub-Scheme on Formulation of GIS based Master Plan for AMRUT Cities' and 'Application of Drone Technology for Formulation of GIS based Master Plan for Small and Medium Towns' published by Ministry of Housing and Urban Affairs (MoHUA) in October, 2020.
- vi. Base Map shall be produced on a scale of 1: 4000.

#### 2.2 Deliverables and Time/Payment Schedule

The Consultant will be required to make a presentation before the Consultancy Evaluation & Review Committee (CERC) within a week of submission of each of the above particulars. The Consultant will be required to submit the status/work progress report of each quarter to the Nodal Officer at Town & Country Planning Office. The observations/suggestions of the Nodal Officer will be incorporated in the next stage of data generation and submission.

#### 2.3 Procedure for Monitoring & Review of the Assignment

The Consultant's work will be monitored and reviewed by a Consultancy Evaluation and Review Committee (CERC) under the Chairmanship of State Mission Director, AMRUT, Govt. of Mizoram.

The consultants shall submit each of the above-mentioned deliverables as per the schedule mentioned above. This will be followed by a presentation to the department and the department



shall give their comments and suggestions in the form of feedback. Subsequently, the consultant will incorporate all such comments and suggestions in final stage report.

#### 2.4 General

- i. The details about the methodology and data outputs in respect of consultancy shall be worked out in the bid offer by the consulting firm.
- ii. All data collected by the Consultant shall be made available to the Client in proper organized format and this data shall remain the property of the Client.
- iii. The data collected and the research results of the Consultancy shall not be divulged to other agencies without the explicit approval of the Client.
- iv. All reports should be submitted in hard and soft copy. Reports should be in Microsoft format, maps and drawings should be in the compatible format of GIS facilities available with the Client.
- v. Monthly Progress Report will be submitted by the consultant to review the progress of the work



#### Section 3. Instruction to Consultant

#### 1. Introduction

- 1.1 The Town & Country Planning Wing, UD&PA Department, Government of Mizoram, henceforth referred as Client will select a Firm/Company/Organization for carrying out the assignment on Geo-Database creation for Lunglei Town of Mizoram under AMRUT 2.0 GIS Sub-Scheme using GIS and Drone/UAV Technology.
- 1.2 Interested consulting firms/consortium may submit one proposal only.
- 1.3 Separate proposals are to be submitted for technical and financial bids.
- 1.4 Proposals are to be submitted in English.

#### 2. Method of Selection

2.1 Selection will be done on the basis of 3-stage process.

In the first stage, pre-qualification information submitted by interested Consultants in prescribed format will be evaluated. Only those who meet the pre-qualification criteria will qualify 1<sup>st</sup> stage and will be considered for 2<sup>nd</sup> stage. In the 2<sup>nd</sup> stage, Technical Proposals will be opened and evaluated and Technical scores will be given by CERC. In the third stage, Financial Proposals of those Consultants who have a technical score of 80% and above will be opened. The Consultant with the L1 bid will be called for further discussions to sign a Contract Agreement, on the recommendations of the CERC.

- 2.2 Interested consulting firms are requested to submit three-stage documents in separate sealed covers:
  - i) Pre-Qualification
  - ii) Technical Proposal
  - iii) Financial Proposal
- 2.3 Consultants must submit an original and two additional copies of Pre-qualification, Technical Proposal and Financial Proposal along with soft copy.
- 2.4 The proposals must be accompanied with a **non-refundable processing fee of 10,000.00 (Rupees Ten thousand only)** in the form of a bank draft drawn in favor of Chief Town Planner, Town & Country Planning Office, Urban Development & Poverty Alleviation Department, Government of Mizoram, Aizawl, payable at Aizawl from any Nationalized Bank.
- 2.5 The Technical Proposal should be accompanied with an Earnest Money Deposit (refundable for all non-successful bidders) of ₹34,000 (Rupees Thirty Four Thousand only) in the form of bank draft drawn in favor of Chief Town Planner, Town & Country Planning Office, Urban Development & Poverty Alleviation Department, Government of Mizoram, Aizawl, payable at Aizawl from any Nationalized Bank.



#### 2.5.1 Response Evaluation

CERC shall evaluate the responses to the RFP and all supporting documents/documentary evidence. Inability to submit requisite supporting documents/documentary evidence by bidders may lead to rejection of their Bids.

The decision of the CERC in the evaluation of Bids shall be final and binding on all the Bidders. CERC may ask for meetings or presentation with the Bidders to seek clarifications or conformations on their Bids.

CERC reserves the right to reject any or all Bids. Each of the responses shall be evaluated as per the criteria and requirements specified in this RFP.

#### 2.5.2 Refund/Adjustment of Earnest Money:

- Earnest money of the successful bidder(s) shall be refunded/adjusted with the final payment to the Consultant.
- Earnest money of the unsuccessful bidder(s) shall be refunded as early as possible.
- No interest shall be paid on Earnest Money.
- Earnest money shall stand forfeited
  - o If the bid is withdrawn at any time before the validity period, or
  - o If the successful bidder fails to execute the contract and /or does not execute performance guarantee/ the project within the stipulated time period.
- 2.6 The outer envelope containing proposal should be marked clearly, "Geo-Database creation for Lunglei town using GIS and Drone/UAV Technology".

2.9 Proposals must remain valid for 90 (Ninety) days after the submission date until validity extended by the Consultant. During this period, the consultant is expected to keep available the key professional staff proposed for the assignment. The client will make the best effort to complete the tendering process within this period. If the client wishes to extend the validity period of the proposals, the Consultants may do so and those who do not agree have the right not to extend the validity of their proposals



#### 3. Pre-Bid Conference

- 3.1 A pre-bid conference will be held on 3<sup>rd</sup> September 2024 at 1:00pm in the office of Chief Town Planner, Town & Country Planning Office, Urban Development & Poverty Alleviation Department, Mizoram New Capital Complex (MINECO).

#### 4. Amendment of RFP Document

- 4.1 At any time prior to the last date for receipt of bids/proposals, the Client, may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the RFP Document by an amendment. The Client may at its discretion extend the deadline for the submission of Proposals.
- 4.2 The amendment will be notified in tender document / RFP published on website and the amendments so published will be binding on them. Interested bidders are requested to visit on frequent basis the department website <a href="https://www.udpa.mizoram.gov.in">www.udpa.mizoram.gov.in</a> to get latest update of the RFP.

#### 5. Preparation of Proposal

#### 5.1 Pre-Qualification Criteria

a) Interested Consultants shall submit information in the prescribed Pre-Qualification Forms provided in Section 4 of this document. Only those Consultants whose responses are found satisfactory will be considered for evaluation of Technical Proposal.

## 5.2 Technical Proposal

- a) In preparing the Technical Proposal, consulting firms are expected to examine the documents comprising this RFP in detail. Material deficiencies in providing the information requested may result in rejection of Proposal.
- b) The Technical Proposal should provide information using the Standard Forms provided in Section 5 of this document only, failing which the proposal may be summarily rejected.
- c) The Technical Proposal shall not include any financial information.

#### 5.3 Financial Proposal

a) The Financial Proposal should be submitted in Standard Forms provided in Section 6 of this document only.



- b) The proposal should be complete, i.e., it should list all costs associated with the Assignment.
- c) The Financial Proposal should clearly identify, as a separate amount, the GST of 18% (local taxes including social security and, 1.5% contingency charges to be deducted by the client), duties, fees, levies, and other charges imposed under the applicable law, on the consultants, the sub-consultants, and their personnel.
- d) The financial proposal should be prepared in Indian Rupees.

#### 6. Submission, Receipt and Opening of Proposals

- i. The original Proposal (including pre-qualification, Technical Proposal and Financial Proposal) shall be prepared in indelible ink. Any corrections must be initialed by the person or persons who sign(s) the Proposals.
- ii. An authorized representative of the consulting firm shall put his/her initials at all the pages of the Proposal. The representative's authorization is confirmed by a written power of attorney accompanying the Proposal.
- iii. The original and all copies of the Pre-Qualification shall be placed in a sealed envelope clearly marked "Pre-Qualification".
- iv. Technical Proposal, including original and all copies shall be placed in a sealed envelope clearly marked "Technical Proposal," and the original and all copies of the Financial Proposal in a sealed envelope clearly marked. 'Financial Proposal', and warning: "Do Not Open with the Technical Proposal." Technical and Financial envelopes shall be placed into an outer envelope and sealed. This outer envelope shall bear the title "Technical and Financial Proposal". This envelope along with Pre-Qualification envelope will be placed in another envelope, sealed and clearly showing the name of the assignment, the submission address, and towns for which the proposal is submitted.
- v. The completed Pre-qualification, Technical and Financial Proposal must be delivered at the submission address on or before the time and date specified.
- vi. Any Proposal received after the closing time for submission of proposals shall be returned unopened.
- vii. After the deadline for submission of proposals the Pre-qualification envelope shall be opened immediately by the Consultation Evaluation & Review Committee (CERC). If the CERC desires, the short-listed consultants may be called for presentation. The information will be evaluated. The Technical Proposal of only the qualifying Consultants will be opened after evaluation process. The Financial Proposal shall remain sealed until technical capability statement of all submitted proposals is prepared and consultants short-listed. The consultant's representative may opt to be present during the financial bid opening. The date will be conveyed by the consultant to the client in advance.

#### 7. Qualification & Evaluation

#### General

7.1 From the time the bids are opened to the time the contract is awarded, if any consultant wishes to contact the Client on any matter related to its proposal, it should do so in writing at the address indicated. Any effort by the firm to influence the Client in the Client's proposal evaluation, proposal comparison or contract award decisions may result in the rejection of the consultant's proposal.



#### **Evaluation of Pre-Qualification**

The authorized CERC will evaluate the Pre-Qualification Forms on the basis of their audited turnover, experience, projects executed, project experience, qualification and experience of key personnel, applying the evaluation criteria specified.

7.6 The minimum technical score required to pass is: 80%.



#### 8. Public Opening and Evaluation of Financial Proposals.

- i. After the evaluation of Technical Proposal is completed, the Client shall notify only those consultants whose proposals have been short-listed of the same and the date and time for opening of financial proposals.
- ii. The Financial Proposals shall be opened publicly in the presence of the consultants' representatives who choose to attend. The name of the consultant, the technical scores, and the proposed amount shall be read aloud and recorded when the Financial Proposals are opened. The Client shall prepare minutes of the public opening.
- iii. The Consultancy Evaluation & Review Committee (CERC) will determine whether the Financial Proposals are complete, (i.e., whether they have costed all items of the corresponding Technical Proposals, if not the client will cost them and add their cost to the initial price), correct any computational errors, etc.
- iv. The Consultant who has bid the lowest amount (L1) will be invited for discussions/ negotiations / clarifications for the purpose of signing a Contract Agreement.

#### 9. Discussions/ clarifications with the successful bidder

- i. Discussion/clarifications will be held in order to reach agreement on all points and sign a contract.
- ii. Discussion/Clarifications will include a discussion of the Technical Proposal, the proposed methodology (work plan), staffing and any suggestions made by the firm to improve the Terms of Reference. The Client and Consultant will then work out final Terms of Reference, staffing, staff-months, logistics, and reporting which will be incorporated in the Contract.
- iii. Discussions/ clarifications will be held at the office chamber of The Chief Town Planner, Town & Country Planning Office, UD&PA on date set by mutual convenience.

#### 10. Award of Contract

- i. The contract will be awarded after the tendering process is complete. Awarding the consultancy work will be in accordance with policies of Government of Mizoram including policies on corrupt and fraudulent practices.
- ii. On award of the consultancy, the Consultant should be required to enter into an agreement with Client for the successful completion of the Consultancy as per the Terms and Reference.
- iii. The firm is expected to commence the assignment on the date and at the location specified in the Contract.
- iv. Termination of the Contract will be in accordance with provisions of the Para 2.6 of General Conditions of Contract. In case of dispute the matter will be resolved within the Judicial Jurisdiction of Mizoram.
- v. The Client will provide the relevant data/reports available. Collecting any other data relevant to the assignment will be the responsibility of the consultants. The Client will provide the necessary introductory letter to get information from other concerned agencies/departments, wherever applicable.

#### 11. Confidentiality

Information relating to evaluation of proposals and recommendations concerning awards shall not be disclosed to the consultants who submitted the proposals or to other persons not officially concerned with the process.



#### 12. Other conditions of payment

- i. No separate TA/DA would be payable in addition to Consultancy fee.
- ii. The GST of 18% and other taxes including 1.5 % contingency charges as applicable under the law would be deducted by the Client from the amount payable as Consultancy fee.
- iii. In case of delay in the conduct of consultancy services within the time fixed or in the event of repudiation of the contract, the Client reserves the right to recover liquidated damages, including administrative expenses, for breach of contract, a sum equivalent to 0.5% (half percent) of total contractual value, which the Consultant has failed to deliver within the period fixed for delivery for each week or part thereof during which delivery is in arrears subject to an overall ceiling of 10% of the total contract price.
- iv. The successful bidder will have to provide a **Performance Guarantee for 10%** of the Consultancy fee at the time of signing the Contract Agreement as per the following details:
  - The guarantee is to be valid upto one year from date of approval of Submission of the Final report.
  - This shall have to be furnished by the Consultant within 15 days from the date
    of issue of a letter accepting the offer of the assignment. The performance
    guarantee shall be submitted in the prescribed form (Section 7, Appendix F)
    from any scheduled commercial bank appearing in the second schedule of RBI
    incorporated in India.
  - The Performance Guarantee Bond and/or any amendment thereto shall be executed on a stamped paper of requisite money value in accordance with Indian laws.
  - No other form of Guarantee shall be acceptable.

#### II. GENERAL CONDITIONS OF CONTRACT

## 1. GENERAL PROVISIONS

## 1.1 Definitions

Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

- (a) "Applicable Law" means the laws and any other instruments having the force of law in India.
- (b) "Contract" means the Contract signed by the Parties, to which these General Conditions of Contract (GC) are attached, together with all the documents listed in Clause 1 of such signed Contract;
- (c) "Contract Price" means the price to be paid for the performance of the Services, in accordance with Clause 6;
- (d) "Member", in case the Consultants consist of a consortium of more than one entity, means any of these entities, and "Members" means all of these entities; "Member in Charge" means the entity specified in the SC to act on their behalf in exercising all the Consultants' rights and obligations towards the Client under this Contract;
- (e) "Party" means the Client or the Consultants, as the case may be, and Parties means both of them;
- (f) "Personnel" means persons hired by the Consultants or by any Sub-consultant as employees and assigned to the performance of the Services or any part thereof;
- (g) "SC" means the Special Conditions of Contract by which these General Conditions of Contract may be amended or supplemented;
- (h) "Services" means the work to be performed by the Consultants pursuant to this Contract as described in Appendix A; and
- (i) "Sub-consultant" means any entity to which the Consultants subcontract any part of the Services in accordance with the provisions of Clauses 3.5 and 4.

## 1.2 Law Governing the Contract

This Contract, its meaning and interpretation, and the relation between the Parties shall be governed by the Law of contract, supplemented by general conditions and special conditions annexed to this contract.

## 1.3 Language

This Contract has been executed in English, which shall be the binding and controlling language for all matters relating to the meaning or interpretation of this Contract.

#### 1.4 Notices

Any notice, request or consent made pursuant to this Contract shall be in writing and shall be deemed to have been made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent by registered mail or facsimile to such Party at the address specified in the SC.



#### 1.5 Location

The Services shall be performed at such locations as are specified in Appendix A and, where the location of a particular task is not so specified, at such locations, whether in the Government's country or elsewhere, as the Client may approve.

## 1.6 Authorized Representatives

Any action required or permitted to be taken, and any document required or permitted to be executed, under this Contract by the Client or the Consultants may be taken or executed by the officials specified in the SC.

#### 1.7 Taxes and Duties

Unless otherwise specified in the SC, the Consultants, Sub-consultants and their Personnel shall pay such taxes, duties, fees and other impositions as may be levied under the Applicable Law, the amount of which is deemed to have been included in the Contract Price.

# 2. COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF CONTRACT

## 2.1 Effectiveness of Contract

This Contract shall come into effect on the date the Contract is signed by both Parties.

## 2.2 Commencement of Services

The Consultants shall begin carrying out the Services after the date the Contract becomes effective.

## 2.3 Expiration of Contract

Unless terminated earlier pursuant to Clause 2.6, this Contract shall terminate with completion of the consultancy in terms of conditions of this agreement to the full satisfaction of the Client.

#### 2.4 Modification

Modification of the terms and conditions of this Contract, including any modification of the scope of the Services or of the Contract Price, may only be made by written agreement between the Parties.

#### 2.5 Force Majeure

# 2.5.1 Definition

For the purpose of this contract "Force Majeure" means any event or circumstance or combination of events or circumstances beyond the reasonable control of either Party including:

- i) Acts of God and nature including
  - typhoon, flood, earthquake, fire, drought, landslide, unusually severe weather condition or other natural disaster; and



- plague or epidemic or quarantine conditions arising therefrom;
- ii) Air crash, shipwreck, train wrecks or failures or delays of transportation;
- iii) Strikes, lock-outs, work-to-rule actions, go-slows or similar labour difficulties other than Governmental Force Majeure that in any way have an effect on the project;

## 2.5.2 No Breach of Contract

The failure of a Party to fulfill any of its obligations under the contract shall not be considered to be a breach of, or default under this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event (a) has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and (b) has informed the other Party as soon as possible about the occurrence of such an event.

## 2.5.3 Extension of Time

Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

#### 2.5.4 Payments

During the period of their inability to perform the Services as a result of an event of Force Majeure, no additional payment will be given however a time extension in the project may be given.

#### 2.6 Termination

## 2.6.1 By the Client

The Client may terminate this Contract, by not less than thirty (30) days' written notice of termination to the Consultants, to be given after the occurrence of any of the events specified in paragraphs (a) through (d) of this Clause 2.6.1 and sixty (60) days' in the case of the event referred to in (e):

- (a) if the Consultants do not perform their obligations under this Contract, within thirty (30) days of receipt after being notified
- (b) If the Consultants become insolvent or bankrupt;
- (c) If, as the result of Force Majeure, the Consultants are unable to perform a material portion of the Services for a period of not less than sixty (60) days; or
- (d)If the Consultant, in the judgment of the Client has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

For the purpose of this clause:

"Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the selection process or in contract execution.



"Fraudulent practice" means a misrepresentation of facts in order to influence a selection process or the execution of a contract.

(e) if the Client, in its sole discretion and for any reason whatsoever, decides to terminate this Contract.

#### 2.6.2 By the Consultants

The Consultants may terminate this Contract, by not less than thirty (30) days' written notice to the Client, such notice to be given after the occurrence of any of the events specified in paragraphs (a) and (b) of this Clause 2.6.2:

- (a) if the Client fails to pay any money due to the Consultants pursuant to this Contract and not subject to dispute pursuant to Clause 7 hereof within forty-five (45) days after receiving written notice from the Consultants that such payment is overdue; or
- (b)If, as the result of Force Majeure, the Consultants are unable to perform a material portion of the Services for a period of not less than sixty (60) days.

## 2.6.3 Payment upon Termination

Upon termination of this Contract pursuant to Clauses 2.6.1 or 2.6.2, the Client shall make the following payments to the Consultants:

- (a) Remuneration pursuant to Clause 6 for Services satisfactorily performed prior to the effective date of termination:
- (b) Except in the case of termination pursuant to paragraphs (a) and (b) of Clause 2.6.1, reimbursement of any reasonable cost incident to the prompt and orderly termination of the Contract.

#### 2.6.4 Failure and Termination

In case of delay in the conduct of Consultancy services within the time fixed or in the event of repudiation of the contract, the Client reserves the right to recover damage for Breach of contract as indicated below:

"To recover from the Consultant as agreed liquidated damages including administration expenses and not by way of penalty, a sum equivalent to 0.5% (half percent) of total contractual agreement, which the Consultant has failed to deliver within the period fixed for delivery for each week or part thereof during which delivery is in arrears subject to an overall ceiling of 10% of the total contract price".

## 3. OBLIGATIONS OF THE CONSULTANTS

## 3.1 General

The Consultants shall perform the Services and carry out their obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional techniques and practices, and shall observe sound management practices, and employ appropriate advanced technology and safe methods. The Consultants shall always



act, in respect of any matter relating to this Contract or to the Services, as faithful advisers to the Client, and shall at all times support and safeguard the Client's legitimate interests in any dealings with Sub-consultants or third parties.

## 3.2 Conflict of Interests

#### 3.2.1 Consultants Not to Benefit from Commissions, Discounts, etc.

The remuneration of the Consultants pursuant to Clause 6 shall constitute the Consultants' sole remuneration in connection with this Contract or the Services, and the Consultants shall not accept for their own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Contract or to the Services or in the discharge of their obligations under the Contract, and the Consultants shall use their best efforts to ensure that the Personnel, any Sub-consultants, and agents of either of them, similarly shall not receive any such additional remuneration.

## 3.2.2 Consultants and Affiliates not to be Otherwise Interested in Project

The Consultants agree that, during the term of this Contract and after its termination, the Consultants and their affiliates, as well as any Sub-consultant and any of its affiliates, shall be disqualified from providing goods, works or services (other than the Services and any continuation thereof) for any project resulting from or closely related to the Services.

## 3.2.3 Prohibition of Conflicting Activities

Neither the Consultants nor their Sub-consultants nor the Personnel shall engage, either directly or indirectly, in any of the following activities:

- (a) During the term of this Contract, any business or professional activities which would conflict with the activities assigned to them under this Contract; or
- (b) After the termination of this Contract, such other activities as may be specified in the SC.

## 3.3 Confidentiality

The Consultants, their Sub-consultants, and the Personnel of either of them shall not, either during the term or within two (2) years after the expiration of this Contract, disclose any proprietary or confidential information relating to the Project, the Services, this Contract, or the Client's business or operations without the prior written consent of the Client.

#### 3.4 Insurance to be taken out by the Consultants

The Consultants (a) shall take out and maintain, and shall cause any Sub-consultants to take out and maintain, at their (or the Sub-consultants', as the case may be) own cost but on terms and conditions approved by the Client, insurance against the risks, and for the coverage, as shall be specified in the SC; and (b) at the Client's request, shall provide evidence to the Client showing that such insurance has been taken out and maintained and that the current premiums have been paid.

#### 3.5 Consultants' Actions Requiring Client's Prior Approval

The Consultants shall obtain the Client's prior approval in writing before taking any of the following actions:



- (a) Entering into a subcontract for the performance of any part of the Services,
- (b) Appointing such members of the Personnel not listed by name in Appendix C ("Key Personnel and Sub-consultants"), and
  - (c) Any other action that may be specified in the SC.

## 3.6 Reporting Obligations

The Consultants shall submit to the Client the reports and documents specified in Appendix B in the form, in the numbers, and within the periods set forth in the said Appendix.

## 3.7 Documents Prepared by the Consultants to be the Property of the Client

All plans, drawings, specifications, designs, reports and other documents and software submitted by the Consultants in accordance with Clause 3.6 shall become and remain the property of the Client, and the Consultants shall, not later than upon termination or expiration of this Contract, deliver all such documents and software to the Client, together with a detailed inventory thereof. The Consultants may retain a copy of such documents and software. Restrictions about the future use of these documents, if any, shall be specified in the SC.



#### 4. CONSULTANTS' PERSONNEL

# 4.1 Description of Personnel

The titles, agreed job descriptions, minimum qualifications and estimated periods of engagement in the carrying out of the Services of the Consultants' Key Personnel are described in Appendix C. The Key Personnel and Sub-consultants listed by title as well as by name in Appendix C are hereby approved by the Client.

# 4.2 Removal and/or Replacement of Personnel

- (a) No changes shall be made in the Key Personnel. In case it becomes incumbent to change any one of key personnel, the Consultants shall forthwith provide as a replacement a person of equivalent or better qualifications with approval of the Client.
- (b) If the Client finds that any of the Personnel have (i) committed serious misconduct or has been charged with having committed a criminal action, or (ii) have reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Consultants shall, at the Client's written request specifying the grounds thereof, forthwith provide as a replacement a person with qualifications and experience acceptable to the Client.
- (c) The Consultants shall have no claim for additional costs arising out of or incidental to any removal and/or replacement of Personnel.

#### 5. OBLIGATIONS OF THE CLIENT

## 5.1 Assistance and Exemptions

The Client shall use its best efforts to ensure that the Government shall provide the Consultants such assistance and data as specified in the SC.

## 5.2 Change in the Applicable Law

If, after the date of this Contract, there is any change in the Applicable Law with respect to taxes and duties which increases or decreases the cost of services rendered by the Consultants, then the remuneration and reimbursable expenses otherwise payable to the Consultants under this Contract shall be increased or decreased accordingly and corresponding adjustments shall be made to the ceiling amounts referred to in Clause 6.2.

#### 5.3 Services and Facilities

The Client shall make available to the Consultants the Services and Facilities listed under Appendix E.



#### 6. PAYMENTS TO THE CONSULTANTS

## 6.1 Lump Sum Remuneration

The Consultant's total remuneration shall not exceed the Contract Price and shall be a fixed lump sum including all staff costs, Sub-consultants' costs, printing, communications, travel, accommodation, and the like, and all other costs incurred by the Consultant in carrying out the Services described in Appendix A. Except as provided in Clause 5.2, the Contract Price may only be increased above the amounts stated in clause 6.2 if the Parties have agreed to additional payments in accordance with Clause 2.4.

## 6.2 Contract Price

The price payable in local currency is set forth in the SC.

# 6.3 Payment for Additional Services

For the purpose of determining the remuneration due for additional services as may be agreed under Clause 2.4, a break-up of the lump-sum price is provided in Appendices D and E.

## 5.4 Terms and Conditions of Payment

Payments will be made to the account of the Consultants and according to the payment schedule stated in the SC. First payment shall not be released till the performance guarantee is executed by the Consultant. Subsequent payments shall be made in accordance with the conditions listed in the SC on submission of an invoice by the Consultants.

#### 7. SETTLEMENT OF DISPUTES

#### 7.1 Amicable Settlement

The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Contract or its interpretation.

## 7.2 Dispute Settlement

Any dispute between the Parties as to matters arising pursuant to this Contract that cannot be settled amicably within thirty (30) days after receipt by one Party of the other Party's request for such amicable settlement may be submitted by either Party for settlement in accordance with the provisions specified in the SC.

The Consultant also agree that their affiliates shall be disqualified for the same period of time from engaging in the said activities.

## 7.2 **Dispute Settlement**

Any Dispute or differences whatsoever arising between the parties out of or relating to the implementation, meaning and operation or effect of this agreement or its execution or the breach thereof shall be settled by arbitration in Aizawl, Mizoram. The parties agree that the sole arbitrator shall be appointed by the Chief Town Planner, Town & Country Planning Office, UD&PA. Parties hereto will raise no objection to the arbitration on the ground that the Arbitrator is a Government servant that he had to deal with matters to which the contract relates or that in the course of his duties as Government servant he has expressed views on all or any of the matters in dispute or difference. It is a term of this agreement that in the event of any difficulty arising by reason of death, resignation, retirement, inability or refusing to act as arbitrator or if the award is set aside by any court for any such reason of procedure, it will be lawful for the Chief Town Planner, Town & Country Planning Office, UD&PA to appoint another person as arbitrator in place of the outgoing arbitrator. In every such case it shall be lawful for the new arbitrator to act upon the record of the proceedings as existent at that stage of the arbitration or to commence proceedings de-novo as the arbitrator in his discretion may decide. The provisions of Indian Arbitration and Conciliation Act, 1996 and any modification thereon shall govern the proceedings. The contract and the arbitration shall be governed by Indian Law only. The Award made in pursuance thereof shall be binding on the parties.

The Civil Courts in Aizawl, Mizoram alone shall have jurisdiction to entertain any suit or matter arising out of this Agreement.
