IST online at Office of the Chief Engineer, PWD, Highway, Mizoram, Aizawl representatives of the bidders (maximum of two) who choose to attend, may attend the online opening of the bids at Office of the Chief Engineer, PWD, Highway, Mizoram, Aizawl on the date and time as mentioned above. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letterhead of the bidder, at the time of opening of bids as mentioned above.
