Bids must be accompanied by Earnest money of the amount specified for the work in the table, in the shape of Demand Draft only in favour of "Superintending Engineer (Transmission Circle), P&E Department, Mizoram" and payable at SBI, Dawrpui Branch, Aizawl, Mizoram only. Tribal tenderers are allowed to submit Earnest money for half the above amount. The bids without earnest money will be summarily rejected.

### **QUALIFYING REQUIREMENTS:**

Qualification of a bidder will be based on meeting the minimum criteria specified below:-

- i) Submission of Earnest money
- ii) Average Annual Financial turn over during the immediate last three (3) consecutive financial years should be 100% of the estimated cost of the works.
- iii) The bidder shall provide evidence satisfactory to the Owner of their capability and adequacy of resources to carry out the Contract effectively. Accordingly, bids shall include the following information:
  - a) Copies of original documents defining the constitutions or legal status, place of registration and principal place of business; written power of attorney of the signatory of the "Applicant" to commit the plant.

- b) Firm's credentials including its past experience in executing similar type of works and also the list of ongoing projects.
- c) List of plant, machinery, manufacturing and testing facilities.
- d) List of manpower with qualification and designations.
- e) The tenderer should possess a valid Electrical Contractor License Class-I authorizing to undertake construction of 33kV lines issued by Mizoram Electrical Licensing Board.

The Owner will assess the capacity and capability of the Bidder in Qualification Stage, to successfully execute the scope of work covered under the package within stipulated completion period. This assessment shall include

- i) Document verification
- ii) Details of works executed, works in hand, anticipated in future and balance capacity available for the present scope of work.
- iii) Details of plant and machinery, manufacturing/ testing facilities, safety equipments, manpower and financial resources.
- iv) Details of quality system in place.
- v) Past experience and performance.
- vi) Customer feedback if any.
- vii) Banker's feedback etc. if any.

P&E Department reserves the right to waive minor deviations if they do not materially affect the capability of the Bidder to perform the contract.
